Tryouts

Returning players do not try out. If your daughter played with the Breakers through the summer program, she keeps her place and nothing is required of her.

New players try out at a normal practice on **Monday October 5th, 2026**. No preparation needed, just arrive ready to play. Coach Myers places players on position, skill and commitment.

Travel is not included in club fees. For Las Vegas, Coach Myers picks the hotel from the options the organizers assign. The team stayed at the MGM last year and the Luxor the year before.

The Phoenix dates run into the national championship dates, so a team cannot do both. It is only for a team that does not qualify. We will know in the spring.

SCSN registration	One time. USA Volleyball membership for the season.	\$80
YMCA court fees	\$100 a month for ten months, or \$1,000 up front. Same total either way.	\$1,000

Commitment and tournament fees

Season commitment and refunds

Joining the Breakers is a commitment for the season. When your daughter takes a roster spot, Coach Myers builds the team around her and commits to court time, coaching and tournament costs for the whole season.

- Your first payment holds her spot and is non-refundable.
- Each quarterly payment is non-refundable once that quarter has started.
- If your daughter needs to step away for a valid reason, like an injury or a family move, talk to Coach Myers. We will work it out fairly.

We keep dues low by keeping the club full. Committing for the season is how we do that.

Tournament fees

Separate from club dues and billed separately. The club pays one entry fee for the entire team, then divides it evenly across the roster whether or not every player attends. Travel and hotels are not included.

You will know your tournament costs the week of October 6th

Teams are set on October 5th and 6th. Once Coach Myers knows how many players are on each roster, he can work out each family's share. You will get a separate invoice for each tournament.

Player and parent commitment

Who we are

The Breakers are a small club, started by Scott Myers in 2012. We run teams at 11U, 12U, 13U and 14U. The club stays deliberately small, so every player gets real coaching, reaches her potential, and has a good time wherever we play.

Our goal

We are here to encourage your daughter to become a better volleyball player, build skills, team spirit, and confidence to carry her on and off the court.

We expect her to show up, work hard, be kind to her teammates, own her mistakes, and treat the other team members, officials and coaches with respect.

Practice

Showing up is what makes a player, and it is what makes a team. Tell Coach Myers about an absence as early as you can. If weather cancels a practice, you will be notified via the BAND app as soon as possible.

Communication

- BAND app. Day to day messages, reminders and schedule changes. Please turn notifications on.
- Email. Club updates, fees and forms.
- Text. Urgent things only. Coach Myers, 949-701-5484.

Tournaments

Events marked "Required" on the schedule are ones the team is entered in, and players are expected to attend. If she cannot make one, tell Coach Myers as soon as you know.

Tournament fees apply whether or not a player attends, because the club pays the entry fee in advance and divides it across the roster. Missing an event does not affect a player's place on the team.

If the club withdraws from an event, the fee is refunded or put toward the next one.

Families arrange and pay for their own travel, meals and hotels. Some tournaments require teams to stay at a designated hotel, and we pass on booking instructions when that applies.

Officiating

Every player officiates at tournaments. That can mean line judging, scoring or running the scoreboard. Players also shag balls during the other team's warm up unless a coach says otherwise. It is part of how we carry ourselves.
